Be sure to keep this info updated, so your account stays compliant with our Seller Agreement.





Accessing your Tax Information

From Seller Center, click "Settings" and then click "Taxes."

Tax Nexus

First up is setting your Tax Nexus. This page shows a list of states where you may have nexus (aka the sales tax requirements for each state).

- 1. To set or update sales tax nexus for a particular state, click the state name. There will be a green dot next to the states where you have previously set up tax nexus. If this is your first time visiting the page, you will not see any green dots. You can always return to this page to update your tax nexus in the future.
- 2. After you click a state, a page will appear that lists all of the sub-states. Sub-states are the counties, districts, and cities within a state that have their own sales tax laws and rates. Some have no sub-states, while others have thousands. Certain states (e.g., WA, MN, CT, IA, OK, PA, SD, NJ, AL, DC, NE, SC, NY, ID, AR, IN, KY, NM, ND, RI, VA, VT, WV, WY, OH, AZ, CA, CO, ME, MD, MA, NV, TX, & UT) are selected by default because their sales tax are collected and remitted directly by Walmart.



3. There are three flows for configuring sub-states (see next pages for instructions):

Flow 1: State has no sub-states

Flow 2: State has sub-states

Flow 3: State has only inherited sub-states



Here's an example of tax nexus set for the 50 U.S. states and Puerto Rico.

Nexus Click the name of the state(s) where you collect sales tax. Some states may have subjurisdiction-level nexus for you to select. For more information, read Configuring Sales Tax Collection.

2 Tax Nexus (Continued)

Flow 1: State has NO sub-states

Some states, like Connecticut, do not have sub-states because they charge sales taxes evenly throughout the state.

- 1. For states with no sub-states, you'll only set nexus at only at the state level.
- 2. After clicking into the state, a window will open to confirm your nexus selection.
- 3. Click "Confirm" to recognize your nexus in that state.
- 4. To undo, click the state again and confirm you no longer have nexus in that state.

Tax Nexus (Continued)


Flow 2: State has sub-states

In some states, like Wisconsin, you may have nexus at the state-level and/or in sub-states.

- 1. Click the state name, check the state as a whole (if applicable) and/or all of the sub-states where you have nexus.
- 2. For some scenarios, you may want to confirm nexus ONLY at the sub-state level and NOT at the state level. To do this, DON'T check the state.
- 3. Click "Confirm" to recognize your nexus in that state and sub-states.
- 4. To undo or update, click the state name again, make and re-confirm your selections.



Some sub-states are locked because they inherit their nexus from the state level. For example, if you select "Wisconsin", all locked sub-states will automatically have nexus too.



Tax Nexus (Continued)

Flow 3: State has ONLY inherited sub-states

Some states, like Ohio, have many sub-states within it, but all of the sub-states inherit that state's nexus setting.

1. Once you click "Confirm Nexus Settings", all of the sub-states will inherit their nexus from the state itself. For example, if you check off Ohio, every sub-state within Ohio will have nexus as well. You can still search or filter for specific sub-states, but you can't modify their nexus individually.

3 Shipping Sales Tax Codes

For each shipping method you support (value, expedited, etc.), you must provide a sales tax code. This helps us know what to charge Walmart customers for shipping. Click below to learn more about shipping sales tax codes.
